Rhodes and other Tigard cops have not even lessened the amount they're shooting, death threats and harassing me (I have huge burns all over my abdomen from them) so Officer Christian is either not really doing a thorough investigation or he is doing it so subtly those cops (signed) don't feel pressured to stop shooting me. I've given Officer Christian enough evidence to get those cops arrested and prosecuted including pictures of my burns all over my legs and abdomen etc. also my ex-neighbor took pictures in his attempted murder.
