The Bullitt Foundation has granted an award of \$35,000 to support the following three Cascadia USDN activities: 1) establish shared approaches to improve performance of multifamily residential buildings in the areas of energy and water efficiency, recycling, composting, indoor air quality, and transportation options while integrating issues of equity and affordability; 2) an annual Cascadia Network meeting in early 2015; and 3) the coordination of quarterly Cascadia network conference calls.
