

ORDINANCE No. 186878

*Pay claim of Johnny Oak in the sum of \$47,500 involving the Portland Police Bureau.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Johnny Oak, through his attorney, Todd Peterson, has filed a bodily injury claim against the City for damages suffered in a vehicle vs. pedestrian collision that occurred on November 20, 2013.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$47,500, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$47,500 made payable to Peterson Law Offices Trust Account.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.




