

ORDINANCE No. 186905

*Authorize Intergovernmental Agreement with Tri-County Metropolitan Transportation District of Oregon to provide exclusion hearings. (Ordinance)

The City of Portland ordains:

Section 1. The Council Finds:

1. The City provides administrative hearings services for exclusion programs through the City's Code Hearings Officer.
2. The Tri-County Metropolitan Transportation District (Tri-Met) desires to utilize the City's Code Hearings Officer to provide administrative hearings services for Tri-Met's exclusion program.
3. It is an appropriate and efficient use of governmental resources for the City and Tri-Met to enter into an intergovernmental agreement for the city to provide hearings services for all exclusions ordered by Tri-Met within the Tri-Met district.
4. Tri-met has agreed to pay the City for the cost of providing this service.
5. The Code Hearings Officer will maintain records for the costs of providing hearings under this agreement.

NOW THEREFORE, The Council Directs:


- a. The Auditor is authorized to sign an agreement, substantially similar with the attached Exhibit A, with Tri-Met to provide administrative hearings for all exclusions ordered by Tri-Met within the Tri-Met district.
- b. The Auditor is authorized to sign amendments to the agreement authorized by section a. above.

Section 2. The Council declares an emergency exists because of Tri-Met's need to provide timely exclusion hearings to the public; therefore, this ordinance shall be in force and effect from and after its passage by the Council.

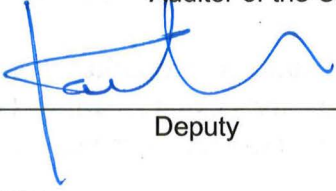
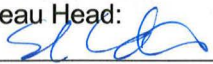
