

7. **BACKGROUND ANALYSIS**

ONI needed to hire someone to write a script for audio description of our emergency training video for people with disabilities. This process entails watching our video and timing it out to insert audio descriptions of the non-verbal action so people who are blind can access the training. I had a very hard time finding anyone other than an outfit in Seattle who do this work and the Seattle group was booked with work through the summer. At the time we did not know that Victoria was an employee for Parks. She did mention when we asked her to do a W9 that she was already a vendor with City but did not seem to understand she was considered an employee of Parks because she only teaches a once a week class for seniors. Because we did not find her in the system as a vendor or an employee we did not think there was a problem.

The work she is doing for ONI is to accommodate people with disabilities and we could not find others who offer this service in the Portland area. The cost of this project will be around \$700
