**1) Legislation Title:** \*Amend an Intergovernmental Agreement with Multnomah County for the Sex Buyers Accountability and Diversion Program (Ordinance; amend Contract No. 30002122)

**2) Purpose of the Proposed Legislation:**

The purpose of this legislation is to extend the existing agreement for an additional two years for education to persons arrested for solicitation of prostitution about the legal, social, and health ramifications of the commercial sex trade. This legislation also amends the agreement to add Sexaholics Anonymous as an additional curriculum provider for the SBAD program. The County contracts with Lifeworks Northwest to provide assistance in the design, development, and implementation of the SBAD program. Lifeworks will administer the SBAD program and retain 10% or \$1,400 for each session, whichever is greater, as reimbursement for administrative and direct costs. A flat fee of \$1,000 will be charged to each participant.

Lifeworks retains 10% or \$1,400 for each session conducted, whichever is greater, as reimbursement for administrative and direct costs. The remainder is distributed to Multnomah

County District Attorney at 33%, the Portland Police Bureau at 34%, and Lifeworks the remaining 33%.
