ORDINANCE No. 186934

Amend a grant agreement with Central City Concern to increase funding by \$136,955 for transitional housing for chronic offenders identified by the Service Coordination Team (Ordinance; amend Contract No. 32001079)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The provision of treatment readiness services, transitional housing for those enrolled in services, and follow-up retention support services to chronic arrestees with chemical dependency issues, is a strategy to reduce nuisance crimes and chronic arrests through the transition of those individuals into treatment.
- 2. Provision of those services is an element of the Service Coordination Team's Housing Rapid Response (HRR) program, which meets goals and objectives of the City of Portland and the Portland Police Bureau.
- 3. Central City Concern (CCC) has successfully provided these services for chronic arrestee homeless adults as part of the HRR program.
- 4. The Police Bureau desires to amend its existing agreement with CCC to add 12 beds to the HRR transitional housing program for homeless single adults with chemical dependency issues.
- 5. Additional funding of \$136,955 is required to add these services. These housing services were previously provided by Volunteers of America. The funds for these services will be moved from that agreement to the grant agreement with CCC.
- 6. The new contract not to exceed amount would be \$1,065,501.

NOW, THEREFORE, the Council directs:

a. The Mayor and Auditor are hereby authorized to enter into an agreement substantially in accordance with the amendment attached as Exhibit A.
