Subject: Accept Revised November 4, 2014 Municipal General Election Results Report to Include Updated Signature Requirement for Recall Petitions

The purpose of the following report is to notify Council that the report regarding November 4, 2014 elections has been updated with a final number for recall petition signature requirements. Information was recently provided by the Multnomah County Elections Division which was not available by the original report deadline provided in City Code 2.04.160 A.

The number of total votes cast for Governor in the City of Portland, listed below, has been updated by Multnomah County to account for precincts which overlap with multiple jurisdictions.

Per ORS Section 249.870, the requisite number of signers on a recall petition is based on the total votes cast for all candidates for Governor at the most recent election. The requisite number of signers is as follows:


