ORDINANCE No. 186944

*Pay claims of Luis Rico and Daniel Rico in the sum of \$24,493 involving the Bureau of Parks and Recreation. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Bodily Injury claims have been made against the City, involving the Bureau of Parks and Recreation, for damages suffered in an auto accident on February 15, 2013. The claimants and settlement amounts are:

Luis Rico

Settlement Amount: \$11,954.34

Daniel Rico

Settlement Amount: \$12,539.36

- 2. The claims have been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claims at this time.
- 3. Risk Management Services recommends the claim be compromised for the total sum of \$24,493.70, subject to the claimants providing the City with signed releases in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$7,500 made payable to Zbinden & Curtis Trust Account. A second check in the amount of \$7,500 will be made payable to the Estate of Daniel Rico and Zbinden & Curtis.
- b. A third check will be made to Progressive Insurance Company in the amount of \$9,493.70.
- c. Risk Management Services will execute payment authorizations in the amounts set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
