Good morning. My name is Susan Stringer and this is Montserrat Shepherd. We are part of the Committee for Demand Redesign, concerned neighbors asking for responsible development in the Eliot neighborhood. We are representing more than 1300 supporters in Eliot and surrounding communities who are here today to address the lot at 2603 NE 7th Avenue and the impact on traffic, parking and the development's excessive density.

Mr. Dan Neal of Paradigm Properties is proposing a 6 story- 62 unit apartment building. The neighborhood around 7th and Russell is a residential community with mostly single family homes, some 2-3 story apartment complexes and a few one story commercial buildings.

We strongly feel that the proposed development does not fit the neighborhood, and are deeply concerned about the impact it will have on 7th Avenue:

* on parking because the proposed underground garage will only have 42 parking spaces and there will be overflow, * on traffic adding hundreds more trips daily,

* on safety since 7th is a narrow street used daily by hundreds of cyclists and pedestrians.

This will only worsen existing conditions for the children who cross daily, without any visible crosswalk, at Brazee Street to attend Irvington School.

In addition, the building's parking garage will have a single entrance on 7th which will create a dangerous pinch point where cars, cyclists and pedestrians will converge on an already congested street.

It is important to note that prior to Mr. Neal's proposal, the Eliot Neighborhood Association had requested the lot be downzoned, and according to the Portland Comprehensive Plan the zoning is proposed to change from High Density to Medium Density limiting the height to 45 feet.

7th has also been proposed as a Neighborhood Greenway. The city defines greenways as: "Streets with low traffic volume and speed where bicycles, pedestrians and neighbors are given priority." We do not believe that 7th is currently a low volume street and that will not improve with the proposed development.

Here are some important statistics from current traffic studies:

South of Knott (where the lot is located):

** Car counts are 71% higher than North of Knott where speed bumps are already in place.

** Traffic speeds are more than 10 mph over the posted 25 mph limit

In contrast, North of Knott the average speed does not exceed 25 mph. It seems obvious that speed-bumps on 7th NORTH of Knott have effectively impacted traffic speeds.

There are also infrastructure concerns. The zoning of this lot, an abandoned gas station, was changed when the Albina plan was adopted. When this zoning change occurred from commercial to high density back in 1990, were the existing ancient clay and brick sewer lines taken into account?

Furthermore 7th avenue is not within the density corridor of Williams Street, MLK and Lloyd Center where 80% of the increased density is expected, making this development even more out of line.

In closing, we would like to ask that the city require the developer to adhere to a height of no more than 45 feet which would mitigate the amount of congestion, to install speed bumps on 7th and Russell to decrease vehicle speed, and to paint a zebra crosswalk across 7th at Brazee to protect our neighbors and our children.

We are here appealing to our elected official's good judgment and common sense. Will this zoning anomaly and its repercussions be a part of your legacy?

Thank you again for allowing us the time to voice our concern and for considering our requests.

Dear Mr. Dustrud and Mr. Neal,

We appreciate your meeting with representatives of our community at the Eliot land use meeting held on July 14th where you showed images of the 82-unit building that you are planning to develop on the corner of NE 7th Ave. and Russell.

It is our view that both design options you are proposing are too large and will actually harm our neighborhood. The scale of your proposed development would cause parking problems, increase traffic, and diminish safety. It would tower over homes, blocking out light, reducing privacy, and detracting from the neighborhood's overall livability and character. Many families and children cross NE 7th Ave. daily to go to Irvington School and other surrounding day cares. The increased traffic in and out of the site would impact safe crossing and put a strain on the local street system.

While we are not opposed to development of the site, your proposal is too tall. There is no building as tall as what you propose anywhere close to this site, not even on nearby Martin Luther King Blvd., Vancouver/Williams, or on N. Mississippi Ave. NE Seventh Ave. is lined with single family homes and a handful of one-story commercial buildings. While the current RH zoning may allow for the size you propose, that does not mean it is the right size for the neighborhood. The city's Comprehensive Plan update proposes downsizing the entire block to the R1 zone in the upcoming year.

We respectfully request that you revise your plans to comply with zoning changes per the City of Portland's Comprehensive Plan update in 2015. The re-zoning of this site in the new plan will still allow you to build as many as 32 units (65 per acre). Your project would then come closer to complying with the city's stated goal of being compatible with nearby single-dwelling residential. The development directly to the north of the site (at the SW corner of NE 7th Ave. and Knott) is well liked by neighbors, and everyone agrees that a similar scale for the NE 7th and Russell site would be appropriate and embraced. We agree that the site needs to be developed but the development should benefit and respect the existing community. With your current proposal, we contend that you are the only one who stands to benefit. It would be best for all concerned if you willingly re-scale your project in accordance with the proposed 2015 zoning update.

SPEED LIMIT CONSIDERATIONS ON NE KNOTT STREET

Studies have shown that there is a 5% risk of fatality when a vehicle travelling at 20mph collides with a pedestrian. The fatality rate increases to 40% when the vehicle is travelling at 30mph. At 40mph the fatality rate approaches 95%.

With the recent death of a 4 year old child struck by a vehicle while crossing SE 136th Avenue on March 1, 2013, renewed attention have been given to traffic calming measures to make our community and our streets safer.

NE Knott street between NE 15th Ave and NE 33rd avenue is a residential street with homes, driveways, trees, sidewalks, children and families, and heavy bicycle traffic. The Oregon statutory speed limit for residential areas is 25mph (ORS 8111.111). There is no compelling reason for the speed limit on this stretch of Knott Street to be set at 30mph, but there are ample reasons to reset the speed limit to 25mph to reflect its residential character.

- 1. Increasing the speed limit on NE Knott street from 25mph to 30mph adds no appreciable commuting value. The average amount of time saved in a daily commute by increasing the speed limit on the stretch of this road from 25mph to 30mph is 15-20 seconds. And yet, as the statistics show, the danger posed to residents of the street, bicyclists, students walking home from school, families with children is increased dramatically with the higher speed limit.
- 2. The ODOT has established a process whereby engineering studies are undertaken as part of the process of restating speed limits. The reason for these studies is ostensibly to set the speed limit at the speed at which drivers are driving. The conceptual basis behind this is based upon research showing drivers on higher speed highways will, within certain limitations, drive at the highest speed they feel appropriate. These studies have been done on higher speed highways, however, and it is obvious that this laissez faire approach breaks down with lower speed roadways in residential and business areas. This is why the ODOT publishes statutory speed limits, this is why there are many and all variety of traffic calming devices all over the city, and this is why highway speed zones are often heavily patrolled to remind drivers that the speed limits are decreased.

Such engineering studies have confirmed that vehicles are travelling at higher speeds on NE Knott Street. There are no stop signs or other traffic calming devices on the entire stretch of NE Knott between NE 24th Ave and NE 33rd Ave. Speeds over 50mph have been documented on this stretch of street. I witness daily high speed driving on NE Knott street, I have had one near death experience, and I documented one truly astonishing display of extremely high speed in a highly modified vehicle.

The problems with simply allowing cars to drive at whatever speed they feel appropriate on NE Knott street are many. To begin with, since the speed is already posted prominently at 30mph, we have a classic "chicken and egg" situation, in which there is no incentive for drivers to

proceed slower than 30mph. Any engineering results will be distorted, if not rendered useless by this signage.

Most drivers recognize a 25mph speed limit as indicative of a residential area, and posting a higher speed limit encourages drivers to ignore the residential character of the area. It encourages a culture of lawlessness as I can attest from my own observations. This is in contradistinction to the character of the street, which is decidedly not a high speed highway.

Additionally the ODOT makes it very clear that pedestrian and bicycle movements, multiple access points and public testimony must be taken into consideration when setting speed limits on any stretch of roadway. The character of the street as a major east-west bicycle route is clear to anyone living along the road. Every day throngs of students can be seen crossing and walking along the street to and from Grant High. Families live on the street and walk along it, as well as joggers, children, children on bicycles, pedestrians with pets. There are innumerable driveway cuts along the entire length of the street.

3. There is ample precedent for the establishment of speed limits in the city to reflect safety concerns rather than the impartial data of speed studies. Oregon law recognizes the city government as the road authority of all highways, streets, roads, alleys within its boundaries (ORS 810.010). The city recently decreased the speed limit on NE Belmont Street from 30mph to 25mph, despite traffic engineering studies showing vehicles travelled at or near 30mph. This was due to a citizen complaint regarding unsafe conditions on that street with the higher, 30pmh speed limit.

The speed limit on NE Knott east of 33rd Ave was decreased to 25 mph for the same reasons.

The Oregonian recently reported the city is considering taking jurisdiction of a portion of 82nd avenue from the state in order to be able to set the speed limit at a level it deems appropriate for safety concerns.

Speed studies demonstrate multiple areas in the city in which average speeds exceed 25mph and yet, in the interests of safety, the city has not posted speed limit signs to reflect those higher average speeds. These include locally NE wisteria, NE Alameda, NE 47th, and NE Williams (average speeds on this road are flagrantly higher than the posted limit).

 Traffic calming measures are in place all over the city to nudge down average speeds and increase safety. This directly contradicts the idea that automobiles must be free to travel ad whatever speed they feel appropriate.

Klickitat street between NE 7th Ave and NE 33rd ave was converted to a Neighborhood Green Way. The stop signs were removed and, due to fears that vehicles would travel at higher speeds on that long stretch of street, speed humps were installed. As Eileen Dent indicated to me "speed humps mitigate the effects of stop signs—stop signs were there for safety at every other intersection". Obviously, in this situation, the natural driving tendencies of vehicles—to speed up on a long straight stretch of road—were deemed secondary to safety considerations of a residential area. These natural driving tendencies were then quashed with speed bumps. As someone who bicycles daily to work I can also confirm that very few bicycles use that stretch of Klickitat despite the "Greenway" designation. Almost all bicycles travel east-west along NE Knott street.

Recently Speed Humps were installed on Wisteria to slow traffic and to otherwise thwart the natural tendencies of drivers to travel faster on that stretch of road (this was done after concerns were expressed by the neighborhood association, and were instituted despite a citywide discontinuation of the speed hump program which was already in place at that time).

Traffic calming devices are present on NE 15th street, NE 21st street, NE 24th street—all higher volume streets, but all streets in which it was felt safety considerations trumped any other concerns.

- 5. Despite declarations by traffic engineers that speed limit signs do not work, there is ample evidence that speed limits are used to increase safety and when properly applied, they do work. The Oregonian recently reported that the Oregon Legislature approved photo radar to patrol highway work zones—and speeding fell 23%. There are often compelling reasons—almost always related to safety--to limit drivers to speeds at which they may not otherwise naturally drive.
- 6. At multiple points in the Grant Park/Irvington area, actual barriers stopping all traffic have been installed at the request of neighborhood groups. Such drastic actions, always undertaken to increase safety (barriers are the ultimate "traffic calming" device), completely contravene any speed study considerations, any considerations regarding convenience for commuters and any vehicle pollution and fuel efficiency considerations. Again, more evidence that safety considerations can reign primary in road design and road use.

7/29/2014

This is a good proposed change (from RH to R1). The recent development proposal (for a new, 7 story apartment building with underground parking) for NW corner of NE7th & Russell is totally out of scale with existing single family homes along the street. This would be disastrous for the neighborhood in terms of parking, traffic, light and livability.

7/29/2014

I strongly support the change to R1 zoning. Such a change would encourage development that fits the scale and feel of the neighborhood. Development allowed by R1 zoning would likely increase property values in the neighborhood, while development allowed under the exist zoning would likely decrease surrounding property values.

7/29/2014

The current zoning of RH is very inappropriate and out of place for the eastern 2/3 of the block. The existing development fits within the code for R1 and will be in compliance. The change maintains the objective of higher density but will protect the recent development in the area as well as protect the investments residents have made in the the surrounding neighborhoods. You might even consider R2 or R2.5 to match the blocks north and sound. Regardless, well done!

7/29/2014

The current proposal for a high rise apt building on the corner of 7th and Russell is totally out of character with our neighborhood. The traffic and parking in the neighborhood are already an out of control situation. There are children in our neighborhood who cross 7th to go to school; there is no stop or crosswalk at 7th and Brazee, and I have seen several near misses. The proposed high rise will stress a neighborhood of single family historic homes, and to have an outside developer who cares nothing for the quality of life here is not only poor planning, but bad for the future of Portland. Lets be a model city, not another Los Angeles. Lets have this development built under the new R1 plan.

7/29/2014

The existing RH zone is completely incongruent with all surrounding development. New construction at surrounding properties within the last 15years or so has been of an R2.5 nature. Properties across the street either direction are R5. The street and sewers cannot well accommodate the RH level of density. There should be a moratorium placed on any RH development proposal until the proposed change to R1 can be considered and implemented. R1 would at least double the density of all nearby properties, and is the maximum that should even be considered for this block.

I completely agree with the previous comments that: the current zoning needs to change to R1 to fit the scale of the neighborhood; the proposal for a 7-story apartment building on NE 7th

Russell would be a disaster for neighbors, dominating the skyline, blocking light, and decreasing livability and property values; any new development should be built under the new R1 plan. By proposing a building so out of scale, the developers are exploiting an obvious oversight in the zoning of that block to the detriment of the neighborhood and the city. Let's not let it happen.

It's unfortunate that there is not a multifamily zone that allows more density than R-1, but not as much height as RH.

The downzoning to R1 and R2.5 of parts of the Eliot Historic Conservation District and the block between 7th and MLK, Knott and Russell is extremely important to protect these areas and their current character. That is especially true of the RH to R1 zoning on that 7th Ave. parcel. BUT... that raises the question of why similar protective down-zoning was not done in the Irvington Historic District just a few blocks away. Irvington has a number of blocks zoned RH with a FAR of 4.0, which would permit structures far out of proportion with the rest of the District and having no trace of compatibility with the District given the requirements of the applicable Historic Resource Review standards. Keeping that RH zoning simply invites endless conflicts between developers seeking to build out to the RH limit and the neighborhood seeking to defend its Historic District character under the guidelines. Further, it ignores established City legal determinations that historic resource review guidelines take precedence over zoning when they are in conflict. Unfortunately your "map app" doesn't seem to allow comments in areas that SHOULD change but are not being changed in the Comp Plan, so I'm entering this comment here as the closest place for it.
