

ORDINANCE No. 186994

Authorize a contract with the lowest responsive bidder for the construction of the SE Division Pl and SE 6th Ave Sewer Rehabilitation Project No. E10630 for an estimated cost of \$720,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Approximately 280 feet of 18" combined sewer on SE Division Pl. between SE 6th and SE 7th Ave. is in severely deteriorated condition and needs to be replaced.
2. Environmental Services has prepared plans and specifications for replacing the deteriorated sewer pipe including sewer manholes, service laterals, inlets and inlet pipes.
3. The estimated cost is \$720,000. Our level of confidence in this estimate is optimal. Funds are available in the Sewer System Operating Fund, FY 2015 Budget, Bureau of Environmental Services, WBS Element E10630.D14.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract for the purpose described in Section 1, with the lowest responsive bidder.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


