

ORDINANCE No. 186998

*Authorize the Director of the Bureau of Environmental Services to amend a Mutual Agreement and Order with the Department of Environmental Quality and Clean Water Services to settle past permit violations and resolve potential future compliance matters in accordance with the terms of the Order. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance number 182542, approved on February 18, 2009, authorized the Bureau of Environmental Services to enter into a Mutual Agreement and Order with the Department of Environmental Quality and Clean Water Services.
2. This agreement requires an amendment to update key delivery dates for required Capital Improvement Projects.
3. There is no cost associated with this amendment.

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to amend the Mutual Agreement and Order for the purpose described in Section 1 and substantially in accordance with the document attached hereto as Exhibit A.

Section 2. The Council declares that an emergency exists because the activities covered by the Amendment are ongoing and are linked to upcoming delivery dates; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
