ORDINANCE No. 187013

*Authorize application to the Oregon Military Department, Office of Emergency Management for a grant in the amount of \$21,576 for the implementation of the FY 2015 State Homeland Security Program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Bureau of Emergency Management's application for the FY 2015 State Homeland Security Program (SHSP) grant will sustain critical disaster preparedness capabilities, not just in Portland but across the region.
- 2. The State Homeland Security grant will support the implementation of State and local homeland security strategies to address the identified planning, organization, equipment, training, and exercise needs to prepare for, respond to and recover from natural or manmade disasters.
- 3. This grant will provide funding to better train and equip Neighborhood Emergency Teams (NETs) located in and around Portland, to better assist residents of their communities after a disaster occurs.

NOW THEREFORE, the Council directs:

- a. The Mayor and the Portland Bureau of Emergency Management are authorized to apply to the Oregon Military Department, Office of Emergency Management for a grant in the amount of \$21,576.00.
- b. The Mayor is authorized to provide such information and assurances required for the grant period.
- c. The Office of Management and Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursements from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by council.
