

ORDINANCE No. 187021

Authorize a contract with the lowest responsible bidder for construction of the Riverview Force Main Replacement Project No. E08866 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has a need to replace the Riverview Force Main to provide long-term reliability of the system.
2. The level of confidence in the estimated cost for a construction contract for the Riverview Force Main Replacement project is optimal.
3. The estimated cost is \$1,900,000. Funds are available in the Sewer System Operating Fund, FY15 & FY16 Budgets, Bureau of Environmental Services, WBS E08866.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract with lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority





