Enter into a Memorandum of Understanding to become a member of the local Joint Terrorism Task Force in conjunction with the Federal Bureau of Investigation (Ordinance)

The City of Portland ordains;

Section 1. The Council finds:

1. The Portland City Council has adopted Resolution No. 37113 "The City of Portland shall enter into a Memorandum of Understanding to become a member of the local Joint Terrorism Task Force (JTTF) in conjunction with the Federal Bureau of Investigation (FBI) and shall repeal Binding City Policy BCP-PSF-7.01 (Resolution; repeal Resolution No. 36859)" as a statement of city policy.
2. The Memorandum of Understanding (MOU) complies with the policies outlined in this Resolution and it serves the interests of the City.

NOW, THEREFORE, the Council directs:

The Mayor is authorized to negotiate and execute on behalf of the City of Portland a Memorandum of Understanding for the City's participation in the JTTF once approved as to form by the City Attorney.


