

ORDINANCE No. 187034

*Pay claim of Ana Guadalupe Mora in the sum of \$10,000.00 involving the Portland Police Bureau. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Ana Guadalupe Mora, through her attorney, George Curtis of Zbinden and Curtis, has filed a bodily injury claim against the City for damages suffered in a vehicle collision occurring on May 6, 2014.
2. The claim has been investigated by Risk Management Services. The investigation indicates the City driver was responsible for the collision. Therefore, we feel it is appropriate to settle the claim at this time.
3. Risk Management Services and the City Attorney's Office recommend the claim be compromised for the total sum of \$13,794.34, \$3794.34 which has been paid already to Kemper Insurance Company, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$10,000.00 made payable to Zbinden and Curtis Trust Account.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.




