ORDINANCE No. 187044

* Authorize a grant agreement with Janus Youth Programs, Inc. for \$15,000 to support one Outreach Specialist to continue outreach to homeless and runaway youth and ongoing training and coaching of volunteers (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Janus Youth operates more than 40 programs designed to meet the culturally specific needs of a very diverse population of marginalized and vulnerable youth, including victims of sex trafficking, teen parents, homeless, runaway and gang affected youth.
- 2. Yellow Brick Road (YBR) is the street outreach component of Janus Youth Programs. YBR works to decrease sexual exploitation of vulnerable youth by building caring and consistent relationships and building trust between youth and service providers.
- 3. The Janus Youth YBR program did not receive its regular Family & Youth Services Bureau (FYSB) Grant that was to fund programming after September 30, 2014. The YBR program operates on an annual budget of \$100,000.
- 4. The Downtown Business Alliance has contributed \$30,000 toward maintaining two positions and a modest outreach supply budget. Janus Youth Programs has leveraged funding from other programming to support the salary of the YBR program supervisor.
- 5. A grant of \$15,000 to Janus Youth would allow YBR to support one Outreach Specialist position to continue daytime outreach throughout the city and ongoing training and coaching of volunteers through September 30, 2015.
- 6. Janus Youth expects to be re-funded by FYSB on October 1, 2015.
- 7. Funding for this grant to Janus Youth Programs is included in the Police Bureau's existing FY 2014-15 General Fund discretionary appropriation.
- 8. Immediate authorization of this agreement by emergency Ordinance is warranted because further delay in funding threatens the continuation of this beneficial program.

NOW, THEREFORE, the Council directs:

a. The Mayor and City Auditor are hereby authorized to enter into a grant agreement with Janus Youth in an amount not to exceed \$15,000 substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares that an emergency exists because a delay would deprive the City and Janus Youth of the benefits of the agreement. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
