ORDINANCE No. 187047

Authorize a contract with lowest responsible bidder for the construction of the SE Hawthorne-Salmon Sewer Reconstruction and Green Streets Project No. E08668 for \$4,590,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services has a need to construct the SE Hawthorne-Salmon Sewer Reconstruction and Green Streets Project in SE Portland. Twenty-three green street facilities to be installed to improve stormwater management and watershed health. Approximately 7,200 feet of new combined sewer pipe needs to be constructed to provide standard sewer service to existing properties.
- 2. The Bureau of Environmental Services has prepared plans and specifications to add new stormwater facilities and replacing undersized combined sewer pipes. The Bureau of Environmental Services requires the furnishing of materials and labor for this project.
- 3. The estimated cost is \$4,590,000. The level of confidence is high. Funds are available in the Sewer System Operating Fund, FY 2014-15 Budget, Bureau of Environmental Services, WBS Element E08668.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract with lowest responsible bidder for the purpose described in Section 1, in the amount of \$4,590,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
