Purpose of proposed legislation and background information:

The purpose of the proposed legislation is to amend the FY 2014-15 budget schedule to transfer appropriation from Contingency to Materials and Services and Capital accounts in the Public Safety GO Bond Fund, Fund 403. The Public Safety Radio Replacement and Fire Apparatus projects are proceeding quicker than anticipated and the projects will need appropriation, currently budgeted in fund contingency, to pay for expenses prior to passage of the Spring Budget Monitoring Process Report.

Financial and budgetary impacts:

The action will amend the budget. \$4,175,000 dollars will be transferred from the Public Safety Radio Replacement Project's contingency account to External Materials and Services and the Fire Apparatus Project will transfer the \$1,772,662 from Contingency to Capital Outlay. Details are in the Budgetary Impact Worksheet below.

An ordinance authorizing the third and final issuance of bonds authorized in the Public Safety GO Bond program will be brought to City Council for approval on March 18, 2015. The revenue recognition of the third sale will not occur until the Spring Budget Monitoring Process.

Community impacts and community involvement:

The Public Safety GO Bond Program has an Independent Citizen Committee overseeing it. They review the project progress and financial statements and report to the CAO who reports to Council. They agree that these expenses associated with this budget amendment are appropriate.
