Needless to say, I was livid! Loss of wages. Extreme loss of Social Security pension retirement protections. Continued loss of creditworthiness. Extreme impoverishment. Homelessness. I had never lived "on the street" until that fateful day. In my view, most assuredly, there are several thousands of participant cases that have yet to be processed correctly to this day! Easily in the multiples of hundreds alone, based on statistics promoted as successes by Central City Concern's Executive Director, as well as Oregon Department of Veterans Affairs and a varietal of nonprofits touting their own fudged numbers! Unacceptable nonsense!

Since that time, Mr. Bray; you, yourself as well as a myriad of Oregon State Bar Members have failed miserably, to this very day, to reasonably correct the overwhelming problems created by you and your associates total lack of proper protocol, procedure and basic common sense. Why would you think nobody would notice?

So very many individuals that THOUGHT they had completed the entire program? Did not! Shameful! No accountability. There was NO beginning, middle AND end! Someone forgot the follow-up! Who? Why? and What for?
