Information about the vacancies was also included in the *Plans Examiner*, an electronic newsletter published by BDS that is widely distributed to BDS customers and stakeholders, as well as neighborhood associations and community groups. Interested members of the public were required to submit an Interest Form and resume to ONI, which were then forwarded to BDS for consideration.

Since individuals must apply for Adjustment Committee vacancies, the participation of stakeholders was crucial to generating qualified applicants and filling the vacant positions.

Appointment

In the summer of 2014, a Media Advisory was circulated regarding two vacancies on the Adjustment Committee, for the positions of Engineering, Financing, Construction, Building Management or Land Development, and Public-at-Large. The position of Engineering, Financing, Construction, Building Management or Land Development position was filled by Charles Benson last fall. In February 2015, Linda Bauer submitted to the Office of Neighborhood Involvement (ONI) an Interest Form to serve of the Adjustment Committee.

Linda has served as the Pleasant Valley Neighborhood Association for 30 years, and as the Land Use Chair for the Southeast Uplift Neighborhood Coalition. She continues to serve as the Land Use and Transportation Committee Chair for East Portland. Linda's extensive background as a neighborhood activist in the area of land use planning qualifies her for the Adjustment Committee's Public-at-Large position. Linda's first, four-year term would be from March 4, 2015 through March 3, 2019.

Adjustment Committee

The Adjustment Committee, authorized under Portland City Code 33.710.070, reviews adjustment requests to the development standards of Title 33 [Planning and Zoning Regulations]. The Adjustment Committee consists of seven members, none of whom may hold public elective office. The committee must include three persons representing the public at large, two members in either urban design, architecture, or landscape architecture, and two members experienced in either engineering, financing construction, management of buildings, or land development. The members are appointed by the Mayor and confirmed by the City Council. The terms shall be a maximum of four years with a maximum of two full terms.

The Adjustment Committee meets on the first and third Tuesday of each month from 9:00 - 12:00.
