Subject: Reappointments and New Appointment to the Development Review Advisory Committee (DRAC)

Portland City Code Title 3.30.030 specifies that members of the Development Review Advisory Committee (DRAC) may serve up to two 3-year terms. Five current DRAC members have completed or are completing their first terms or partial terms (served for prior members who resigned), and are eligible for reappointment. They have all expressed interest in serving on the DRAC and have completed the required interest form. In addition, after a thorough review process, I am recommending a candidate for appointment to a vacant DRAC position for a 3-year term. The table below lists the recommendation and members for reappointment and appointment, along with their DRAC position and status:

Claire Carder, Phil Damiano, David Humber, Maryhelen Kincaid, and Dana Krawczuk have proven to be valuable contributors to the DRAC and its work during their tenure. Their experience and perspectives have greatly aided efforts to streamline and improve the development review process. I am therefore recommending that these five DRAC members be reappointed to their positions for 3-year terms as indicated.

Jennifer Marsicek has 17 years experience in the field of architecture, including the last 10 years with Scott Edwards Architecture. She has worked on a wide variety of development projects, from single- and multi-family residential to retail, government, non-profit, and tenant improvement. Jennifer also has significant community involvement experience; she currently serves as a PBOT Active Transportation volunteer, and has volunteered previously with the PDC on the Fremont/MLK Vision Committee and the MLK Advisory Committee. In addition, she served for 3 years as the King Neighborhood Association Land Use Co-Chair. Jennifer's design experience and community involvement will provide a valuable resource to the DRAC.

With these proposed reappointments and appointment, three vacant positions (Home Builders, Home Remodelers, and Planning & Sustainability Commission) would remain on the DRAC. I have enclosed an updated DRAC membership list for your records.

These appointments will help to ensure the continuation of the good work of the DRAC on behalf of BDS and other City bureaus, the development industry, and the community.

Development Review Advisory Committee:

The Development Review Advisory Committee (DRAC) is a citizen advisory body, representing those with interests in the outcome of policies, budgets, regulations, and procedures that affect development review processes. The purpose of the Committee is to foster a timely, predictable and accountable development review process that implements the City's goals for land use, transportation, housing, economic development, neighborhood livability and the environment. The Committee advocates for and supports consistent and fair application and implementation of regulations.

The Development Review Advisory Committee consists of seventeen members. These members are appointed by the Commissioner-in-Charge and confirmed by the City Council. The members are elected to provide representation of those persons concerned about planning, design and development. The areas of interest of members shall include, but not be limited to, development, planning, construction contracting, design professions, neighborhood association membership, business association membership, historic preservation, environmental organizations, and institutional properties. Members of the Development Review Advisory Committee shall serve no more than two, complete three-year terms.

The DRAC meetings are held the third Thursday of each month from 8:00 to 9:30 a.m.
