

ORDINANCE No. 187053

*Authorize an agreement with American Healthways Services, LLC to promote the use of Portland Parks and Recreation fitness facilities to seniors (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Parks and Recreation (PP&R) is dedicated to ensuring access to recreational and wellness opportunities for seniors in Portland.
2. PP&R and American Healthways Services, LLC, have negotiated an agreement to promote the use of Portland Parks and Recreation's fitness facilities to seniors.
3. The proposed agreement calls for American Healthways Services to compensate PP&R for each visit to a community center by a participating senior in the American Healthways Services program. Participating seniors will receive free access to PP&R's fitness centers. PP&R community centers included in the program: Charles Jordan Community Center, Matt Dishman Community Center, Southwest Community Center, Mt Scott Community Center and East Portland Community Center.

NOW, THEREFORE, the Council Directs:

- a. The Director of PP&R is hereby authorized to execute the Agreement, substantially in the form of the attached Exhibit, and any amendments. All such documents must be approved as to form by the City Attorney.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the program; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
