ORDINANCE No. 187058

* Extend contract with Xerox State and Local Solutions, Inc., for the Red Light Camera System and increase the not to exceed amount by 1,000,000 (Ordinance; amend Contract No. 31000128)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Red light running continues to be the fastest growing type of crash in the urban environment and the City of Portland continues to struggle with crashes caused by red light running. The City of Portland is committed to reducing traffic fatalities and injuries and very positive trends are occurring at intersections with red light camera enforcement.
- 2. On April 1, 2010 ACS State and Local Solutions, Inc. was awarded a contract to provide a Red Light Camera System.
- 3. ACS State and Local Solutions, Inc. was subsequently purchased and now operates as the vendor under this contract as Xerox State and Local Solutions, Inc.
- 4. This contract is funded by receipts of citation revenues from the Red Light Camera System on behalf of the Portland Police Bureau, Traffic Division. Expense and offsetting program revenue appropriations for this program are included in the Police Bureau budget each fiscal year
- 5. Ordinance No. 183672, passed by the Council on April 7, 2010, authorized Contract No. 31000128 for a five year term and now requires renewal.
- 6. Contract No. 31000128 for Red Light Camera System allows for a four year contract extension.
- 7. The additional estimated cost for the Red Light Camera System over a period of four years is approximately \$1,000,000.
- 8. Immediate amendment of this agreement by emergency Ordinance is warranted because further delay threatens the continuation of this beneficial program.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to renew contract 31000128 for a four year term with Xerox State and Local Solutions, Inc. and add \$1,000,000 to the contract not to exceed amount.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks payable to the contractor for the negotiated and executed contract and chargeable to the existing appropriation in the Portland Police Bureau budget for a total not to exceed amount of

\$4,750,000 when demand is presented and approved.

Section 2. The Council declares that an emergency exists because a delay threatens the continuation of this beneficial program; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.


