WHEREAS, at a time when cities, through inclusion and innovation, are leading the way on so many issues, it's disheartening and frustrating to see one pushed backward; and

NOW, THEREFORE BE IT RESOLVED, that we members of the Portland City Commission do so hereby stand with the citizens of Indiana and throughout the country who are asking Indiana Governor Mike Pence to overturn the "Religious Freedom Restoration" Act; temporarily suspend any public employee from travelling to the State of Indiana for City purposes until such time as the "Religious Freedom Restoration" Act has been overturned; and call on civic and business leaders throughout Portland, who have long been stalwart supporters for GLBT rights and against discrimination of any kind, to join us in saying no to discrimination.
