Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary range of two Nonrepresented classifications, effective July 28, 2014.

NOW, THEREFORE, the Council directs:


- a. The following compensation rates are being changed:
