ORDINANCE NO. 187067

Authorize Intergovernmental Agreement with Multnomah County for \$67,796 to share the costs of a Home for Everyone Initiative Director (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

- 1. The Portland City Council on April 10, 2013, through Resolution No. 37010 adopted *A Home for Everyone: A United Community Plan to End Homelessness in Multnomah County.*
- 2. The City of Portland, Multnomah County and Home Forward have responded to the issue of homelessness for many years and recognize their collective role in providing a safety net of services to prevent and end homelessness; and
- 3. The City of Portland made a new investment of City General Funds during the 2014-15 budget process to increase access to housing for priority populations identified in *A Home for Everyone: A United Community Plan to End Homelessness in Multnomah County* of \$500,000 per year.
- 4. The City of Portland, acting through its Portland Housing Bureau (PHB) has been a major funder of the key strategies and services of *A Home for Everyone*.

NOW THEREFORE, the Council directs that:

- a. The Bureau Director is hereby authorized to execute an IGA with Multnomah County in a form similar to the intergovernmental agreement attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Portland Housing Bureau's operating fund budget when demand is presented and approved by the proper authority.
