Purpose of proposed legislation and background information:

The purpose of this Ordinance is to authorize the purchase of network infrastructure products and services, from Mountain States Networking, in the amount of \$505,108, in order to replace end-of-life Cisco products. The network infrastructure is a critical component of the City's computing infrastructure that provides IP communications for all the City's computer applications. The purchase of Mountain States Networking products will fulfil the critical business needs outlined within the work plan of the Bureau of Technology Services Capital Improvement Project (Package: Enterprise Network Life Cycle Replacement), by replacing end-of-life network infrastructure products, and allowing the City's Networking Team to immediately deploy the equipment needed to make the City's network up-to-date, supportable and secure.

This Ordinance will not change specific City policies.
