Jonath is a known and trusted member of the Latino community who has a reputation for producing results.

Don Grotting

Don Grotting is in his 5th year as Superintendent of the David Douglas School District, the largest in Oregon, which serves roughly 11,000 East Portland students and includes David Douglas High School. Don was named Oregon Superintendent of the Year in 2014 by the Confederation of Oregon School Administrators for the amazing work he is doing with a district in which 80% of its students come from a low-income home, and where a majority speak English as a second language.

Dion Jordan

Dion Jordan has been a highly respected and valued community leader in the City of Portland for over a decade. Dion, a nationally known speaker, success strategist and author, is often sought after by both political and community leaders for his integrity, leadership and passion for people and their communities. In addition, he is the founder of the Young Speakers Society, an organization that helps youth and young adults build confidence through public speaking. Karen Loper

Karen Loper grew up in Portland and spent her career with Portland Parks & Recreation. Starting in college, she held various positions over time including Volunteer Coordinator, Outreach and Communication manager. Karen's broad exposure over time to virtually every aspect of the suite of Parks & Recreation services makes her an invaluable addition to this committee. She has a deep understanding of the roles and responsibilities of employees and volunteers of PP&R and also how upgrades to the park system help staff respond to community recreational needs. She also understands the budgeting protocols: both monitoring and managing funding to meet bureau-wide objectives. Karen retired in 2012 after four years as Assistant Director. She worked on many bond and levy programs (before, during and after) ensuring the public was involved and informed throughout the process.

Zari Santner was Director of Portland Parks & Recreation from 2003 until she retired from the City of Portland in 2011. A landscape architect by training and native of Iran, Zari will bring a unique and comprehensive understanding of Portland Parks & Recreation to the Bond Oversight Committee.
