

ORDINANCE NO. 187106

* Authorize application to the Oregon Parks and Recreation Department for a grant in the amount of \$750,000 for development of the Gateway Green Park Project. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Oregon Parks and Recreation is soliciting applications for grant funding through the Local Government Grants program, which provides project funding for the development of outdoor recreation facilities.
2. Portland Parks & Recreation is seeking funding through OPRD's Local Government Grant Program to develop the trail system, the nature play area, water service, a concrete pad, lighting, signage, and fencing at the Gateway Green site. This will improve recreational access in the area for the 26,000 residents living in a 1.5 mile area around the project site.
3. Local match in the amount of \$343,100 will be provided by funds from System Development Charges.
4. Friends of Gateway Green has raised \$826,500, partially through a METRO challenge grant, in support of the project and have applied for additional funds.
5. Portland Parks & Recreation will provide funding for on-going operations and maintenance of this park and recreation facility should grant funds be awarded. Portland Parks & Recreation has secured operations and maintenance monies, in the amount \$198,000, to fund O&M annually at this site.

NOW THEREFORE, The Council directs:

- a) The Mayor is authorized to make application to the Oregon Parks and Recreation Department for a grant in the amount of \$750,000.
- b) The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c) The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
