

**ORDINANCE No. 187119**

\*Pay claim of Mary Haney in the sum of \$7,699 involving the Bureau of Environmental Services. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Mary Haney has filed a property damage claim against the City for damages suffered in a stormwater flooding event on June 16, 2014, involving the Bureau of Environmental Services.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$7,699.15, subject to the claimant providing the City with a release in a form to be approved by the City Attorney. Risk Management has advanced \$5,000.00 of this amount, leaving a payment pursuant to this Ordinance of \$2,699.15.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$2,699.15 made payable to Mary Haney. (Total settlement amount is \$7,699.15; of which \$5,000 has previously been paid.)
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
