

ORDINANCE NO. 187122

Amend subrecipient contract with JOIN to add \$3,468 for enhanced outreach and operations during winter severe weather events for a total not to exceed \$1,780,741 (Ordinance; amend Contract No. 32001124)

The City of Portland ordains:

Section 1. The Council finds that:

1. Through Ordinance No. 186666, the Council authorized Contract No. 32001124 between JOIN and the City in the amount of \$1,285,000 to provide street outreach and housing placement and retention services. Through Ordinance No. 186956, the Council authorized an amendment to increase the contract funding by \$492,273 to include additional housing placement for vulnerable adults, veterans, and people experiencing homelessness in Multnomah County east of the Portland City limits.
2. During severe weather events throughout the winter of 2014-2015, JOIN provided enhanced outreach and operations under direction of the City and in support of City severe weather response.
3. PHB and JOIN desire to amend existing Contract No. 32001124 with JOIN to add \$3,468 to fund JOIN's enhanced outreach and operations in support of City severe weather response.

NOW THEREFORE, the Council directs that:

- a. The Bureau Director is hereby authorized to enter into a contract amendment with JOIN in a form similar to the amendment attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Portland Housing Bureau's operating fund budget when demand is presented and approved by the proper authority.
