

ORDINANCE No. 187126 As Amended

\* Accept a grant in the amount of \$172,700 and appropriate \$40,000 for FY 2014-15 from the Oregon Department of Justice and the Oregon High Intensity Drug Trafficking Areas program for sworn personnel overtime and program expenses for Portland interdiction efforts (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the Oregon Department of Justice (ODOJ), Oregon High Intensity Drug Trafficking Areas (HIDTA) program for grant funding in March 2014, to support the HIDTA Interdiction Team (HIT) efforts in disrupting and dismantling drug trafficking organizations in Multnomah, Washington, and Clackamas counties by employing a multi-agency approach to significantly impact drug availability in the area;
2. The Oregon Department of Justice was awarded \$3,097,151 by the Office of National Drug Control Policy's HIDTA Program to support initiatives designed to implement the strategy proposed by the Executive Board of the Oregon HIDTA Program for the grant period January 1, 2015, through December 31, 2016;
3. ODOJ HIDTA has notified the City that it will award a grant to the Police Bureau Drugs and Vice Division in the amount of \$122,700 and \$50,000 pass-through for the Oregon State Police (OSP) Criminal Investigation Division as part of the HIT program;
4. ODOJ HIDTA will reimburse the City a maximum of \$172,700 for investigative overtime and approved program expenses including OSP's programs. No match is required for this grant; and
5. Council declares an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from ODOJ for the Oregon HIDTA program for Portland interdiction efforts in the amount of \$172,700.
- b. The FY 2014-15 budget is hereby amended as follows:  
GRANTS FUND  
Fund - 217  
Business Area - PL  
Bureau Program Expenses - \$40,000

GENERAL FUND

Fund - 100

Business Area - PL

Bureau Program Expenses – (zero)

- c. The Office of Management & Finance Grants Management Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City any subsequent modifications by ODOJ HIDTA for the HIDTA grant, award number G15OR0002A, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


