

ORDINANCE No. 187127

* Accept a grant in the amount of \$36,000 from the Oregon Department of Justice and the Oregon High Intensity Drug Trafficking Areas program for program expenses for Portland Metro Gang Task Force interdiction efforts (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the Oregon Department of Justice (ODOJ), Oregon High Intensity Drug Trafficking Areas (HIDTA) program for grant funding in March 2014, to support the Portland Area Metro Gang Task Force (PAMG) Initiative, which provides the Bureau with the means to assist in the investigation of violent street gang members who are involved in the distribution of controlled substances in the Portland area;
2. The Oregon Department of Justice was awarded \$3,097,151 by the Office of National Drug Control Policy's HIDTA Program to support initiatives designed to implement the strategy proposed by the Executive Board of the Oregon HIDTA Program and approved by the Office of National Drug Control Policy (ONDCP) for the grant period January 1, 2015, through December 31, 2016;
3. ODOJ HIDTA has notified the City that it will award a grant to the Police Bureau Metro Gang Task Force in the amount of \$36,000 and will reimburse the City a maximum of \$36,000 for approved program expenses;
4. No match is required for this grant; and
5. Council declares an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from ODOJ for the Oregon HIDTA program for Portland interdiction efforts in the amount of \$36,000.
- b. The Office of Management & Finance Grants Management Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- c. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City any subsequent modifications by ODOJ HIDTA for the HIDTA grant, award number G15OR0002A, provided such modifications do not

increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
