Reason for the request:

I need to ask Mayor Hales to use his authority as Police Commissioner to make Portland Police do their legal duty to protect me (and my son) from some Tigard cops shooting us with microwave weapons, ultrasound weapons, voice to skull command weapons, Lidar machine sleep deprivation, etc. They shoot me and stalk me 20-24 hrs a day. It is obvious to anyone their intent is to murder me.
Mayor Hales said when I last testified on April 8, 2015 that he would contact his office assistant (Cindy Reyes) and get me some help. I talked to her a few days ago. Mayor Hales hadn't talked to her about this "help" yet so she went to another office employee to ask advice. He or she told her to tell me to call the Women's Crisis Line. I then left. The Women's Crisis line employees have no authority to make Portland Police do their legal duty. (signed)
