\*Amend Intergovernmental Agreement with Oregon Department of Transportation for the Tryon and Stephens Headwaters Neighborhood St Plan Project to increase the grant amount by \$20,000 (Ordinance; amend Contract No. 30004042)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. Council passed Ordinance No. 186596 on May 28, 2014, accepting a Transportation and Growth Management (TGM) grant in the amount of \$106,032 from Oregon Department of Transportation for the Tryon and Stephens Headwaters Neighborhood Street Plan Project and authorizing an Intergovernmental Agreement.
- 2. Oregon Department of Transportation has notified the City of Portland that it will award an additional \$20,000 in TGM funds for the City of Portland, Tryon and Stephens Headwaters Neighborhood Street Plan Project to the Portland Bureau of Transportation making the total grant amount \$126,032.
- 3. The City's required matching amount is \$17,186, or 12% of the Total Project Cost. Bureau of Environmental Services will provide the City's required matching amount of \$17,186 with in-kind services. In addition, Bureau of Environmental Services is overmatching by \$33,864, for a total match of \$51,050, with in-kind services.
- The Termination Date for this Agreement remains June 30, 2015. 4.
- 5. The Bureau's level of confidence in the cost estimates for this planning project is moderate.

## NOW, THEREFORE, the Council directs:

That the Commissioner-in-Charge is hereby authorized to execute an amendment as to form a. by the City Attorney, with the Oregon Department of Transportation for the Tryon and Stephens Headwaters Neighborhood Street Plan Project, in a form similar to the Amendment attached as Exhibit A.

Section 2. The Council declares that an emergency exists because a delay would not allow completion of the plan by the project Termination Date; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
