

ORDINANCE No. 187154

*Pay claim of Markus Maniar in the sum of \$100,000 involving the Bureau of Internal Business Services. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Markus Maniar has filed a workers' compensation claim with the City for an on-the-job injury sustained on October 1, 2012 while employed by the Bureau of Internal Business Services.
2. The claim has been investigated by Risk Management Services. The claim was found compensable. There is future exposure for additional benefits under state workers' compensation law. Therefore, in order to compromise and eliminate future exposure for benefits and reduce expenses to the City's workers' compensation fund, it is prudent to resolve the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$100,000, subject to the claimant executing settlement documents in a form to be approved by the City Attorney, and contingent on all required approvals of those documents.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver checks in the total amount of \$100,000 made payable to James T. Guinn, attorney and Markus Maniar.
- b. Risk Management Services will execute any necessary payment authorizations in the total amount set forth in sub-paragraph (a) above.





