Authorize a contract with the lowest responsive bidder for construction of SW Stephenson & SW Hamilton Drainage and road shoulder improvements BES project E10131 for \$560,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has prepared plans, specifications and estimates to construct this project. This project will provide 2,800 LF of drainage ditch improvements and build two stormwater infiltration facilities to reduce pollutant load to streams and to improve water quality.
- 2. BES requires the furnishing of materials and labor for this project through competitive bidding process.
- 3. The estimated cost is \$560,000. Level of confidence is high. Funds are available in the Sewer System Operating Fund, FY 2016 Budget, Bureau of Environmental Services, WBS Element E10131.C60.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is authorized to execute a contract for the purpose described in Section 1, with the lowest responsive bidder.
- b. The Mayor and City Auditor are hereby authorized to pay for the contract from the Sewer System Operating Fund Budget.
