These areas include distinct districts, such as Albina and Northwest Portland, that have multiple mixed- use corridors in proximity (see the shaded areas in the Urban Design Framework), allowing most residents to live within a short, quarter-mile distance of frequent-service transit and neighborhood businesses. The Inner Ring Districts are also served by a highly interconnected system of streets and sidewalks, and are within a convenient, three-mile biking distance of the Central City’s array of services, jobs, and amenities.</p>	<p>It’s more inclusive to use either factual/standard (e.g., quarter mile) <u>or</u> descriptive (e.g., short).
