Ordinance No. 1500?

An Ordinance authorizing and consenting to the sale, assignment and transfer, to Portland Railway Company, a corporation incorporated under the laws of the State of Oregon in the month of October, 1905, and its successors and assigns, of the rights, privileges and franchises granted and conferred by certain ordinances, resolutions and permits of the City of Portland.

The City of Portland does ordain as follows:

Section 1: The City of Portland hereby consents and agrees that all the rights, privileges, franchises, licenses, easements and immunities, granted or conferred by the City of Portland by the following described ordinances of the City of Portland, to-wit : November 24, 1902, and approved

Ordinance Number 13089, passed by the Common Council/November 25,1902, entitled:"An Ordinance granting to Portland Railway Company, its successors and assigns, the right to construct, acquire and own, and to maintain, operate and use railways and poles and wires and underground conduits, cables and conductors, in the City of Portland, Oregon", and Ordinance Number 13178, passed January 9, 1903 and approved by the Common Council/January 14, 1903, entitled,"An Ordinance to amend gection fourteen of Ordinance No. 13089, of the City of Portland, Oregon, approved November 25, 1902, entitled, An Ordinance granting to Portland Railway Company, its successors and assigns, the right to construct, acquire and own, and to maintain, operate and use, railways and poles and wires and underground conduits, cables and conductors, in the City of Portland, Oregon'", and Ordinance Number 13187, passed by the Common Council January 21, 1903, and approved January 21, 1903, entitled "An Ordinance making an addition to section one of Ordinance number 13089 of the City of Portland, Oregon, approved November 25, 1902, entitled 'An Ordinance granting to Portland Railway Company, its successors and assigns, the right to construct, acquire and own, and to maintain, operate and use, railways and poles and wires and underground conduits, cables and conductors, in the City of Portland, Oregon'", and ordinance No. 13435, passed by the Common Council July 1,1903, and approved July 2, 1903, entitled, "An Ordinance authorizing and consenting to a change in the location of the bridge across Jefferson Street Canyon, authorized by Ordinance Number 13089 to be constructed, maintained, operated and used by Portland Railway Company, its successors and assigns", and approved by the Mayor January 13, 1903 and ordinance number 13177, passed by the Common Council January 9,1903/ and approved by the Board of Public Works January 14, 1903, entitled, "An Ordinance granting to City and Suburban Railway Company, its successors and assigns, the right to construct, acquire and own, and to maintain and use railways and poles and wires and underground conduits, cables and conductors, in the City of Portland, Oregon", and Ordinance No. 14561, approved April 6, 1905, entitled,"An Ordinance granting a permit to Portland Consolidated Railway Company to construct a single or double track railway on Alder Street from the center line of Second Street to the center line of Third Street", and all other rights, privileges, licenses, easements, franchises, immunities and permits, now or formerly held, owned, possessed, used or enjoyed, by Portland Consolidated Railway Company, a corporation of the State of Oregon, may be sold, assigned and transferred to Portland Railway Company, a corporation incorporated under the laws of the State of Oregon in the month of October, 1905, and that said Portland Railway Company and its successors and assigns, may purchase, acquire, take, own, hold, possess, use and enjoy, all of the said rights privileges, franchises, licenses, easements, immunities and permits.

Section 2: Said Portland Railway Company, a corporation, incorporated under the laws of the State of Oregon in the month of October, 1905, shall within, thirty days after the approval of this Ordinance, file with the Auditor of the City of Portland, its written acceptance of this ordinance embodying its written agreement that it will do and perform each and every act and thing required by any of the aforesaid ordinances to be done or performed by the Portland Railway Company, a corporation incorporated under the laws of the State of Oregon in the year 1896, or said City and Suburban Railway Company, or said Portland Consolidated Railway Company, and if said Portland Railway Company, a corporation incorporated under the laws of the State of Oregon in the month of October, 1905, shall fail so to file its written acceptance of this ordinance within said period of thirty days from and after the approval of this ordinance, then and in that event this ordinance shall be void and of no effect.

Portland, Oregon, Nov. 25, 1905

To the Honorable, The Council, Portland, Oregon. Gentlemen:-

In returning you Ordinance No. 15007 without my approval, I would say that this ordinance attempts to authorize the several street railway companies named therein to sell and transfer to the Portland Railway Company their rights under their respective franchises. It is claimed that these companies have the authority to make such transfers independent of this ordinance. If such be the case this ordinance can subserve no useful purpose, and no sufficient reason appears why the companies should desire its passage. If on the other hand this ordinance does confer rights or privileges upon franchise holders which they do not now possess, it is certainly our duty to exact corresponding return from them for the benefit of the City and its inhabitants.

It is evident to all that the favors and privileges that have been bestowed in the past as franchises to the several street railways named in this ordinance now have a market value of millions of dollars, all granted without adequate benefits to the City, and it would seem that this excessive generosity with the property of the public should not be continued.
