

**ORDINANCE NO. 187176**

\*Amend subrecipient contract with JOIN to add \$65,450 to create a landlord response program for veterans exiting homelessness for a total not to exceed \$1,846,191 (Ordinance; amend Contract No. 32001124)

The City of Portland ordains:

Section 1. The Council finds that:

1. Through Ordinance No. 186666, the Council authorized Contract No. 32001124 between JOIN and the City in the amount of \$1,285,000 to provide street outreach and housing placement and retention services. Through Ordinances Nos. 186956 and 187122 the Council authorized two amendments to increase the contract funding by a total of \$495,741 to include additional services.
2. Through the Spring Budget Monitoring Process, the Council allocated \$150,000 in additional Fiscal Year 2014-2015 general funds to support actions to end veterans' homelessness in Multnomah County by the end of 2015. The actions align with strategies identified through A Home for Everyone, the community-wide effort to end homelessness in Multnomah County.
3. A Home for Everyone identified creation of a landlord response program among those strategies prioritized for immediate action. PHB solicited letters of interest from homeless service providers currently serving homeless veterans that wished to create a landlord response program and competitively selected JOIN from among the respondents.
4. PHB and JOIN desire to amend existing Contract No. 32001124 with JOIN to add \$65,450 to fund JOIN's proposed landlord response program.

NOW THEREFORE, the Council directs that:

- a. The Bureau Director is hereby authorized to enter into a contract amendment with JOIN in a form similar to the amendment attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Portland Housing Bureau's operating fund budget when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the amendment must be executed and funds drawn prior to close of City's fiscal year. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
