

## ORDINANCE No. 187178

\* Authorize application to the Federal Emergency Management Agency, through the Oregon Military Department Office of Emergency Management, for the Emergency Management Performance Grant in the amount of \$385,027 for positions and programs (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Federal Emergency Management Agency's (FEMA) Emergency Management Performance Grant (EMPG) Program, provides financial and technical assistance through their Fiscal Year 2015 grant, for the development of all hazard emergency management capabilities to promote planning, response, exercise, training and community outreach.
2. Grant funds will be budgeted for one half of the cost of three planning and preparedness positions for PBEM, one half of the annual rent for PBEM office space, one half of the cost of technology services for the Emergency Coordination Center (ECC), and one half of the Public Alert Hosting contract. All funds received through the EMPG program require a 50% match.

NOW THEREFORE, the Council directs:

- a. The Mayor and the Portland Bureau of Emergency Management (PBEM) are authorized to apply for this grant from the Federal Emergency Management Agency Emergency Management Performance Grant Program.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The Office of Management and Finance (OMF) Grants Office is authorized to perform all administrative matters in relation to the grant application and to submit the required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists to meet grant submittal deadlines. Therefore, this ordinance shall be in full force and effect from and after its passage by council.
