*Pay claim of Christine Smith in the sum of \$39,075 involving Parks Bureau. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Through her attorney John O'Hara, Christine Smith has filed a bodily injury lawsuit against the City for damages suffered in a trip and fall involving Portland Parks and Recreation on August 31, 2012.
- 2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.
- 3. Risk Management Services recommends the lawsuit be compromised for the total sum of \$39,075.00, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- The Mayor and the Auditor are hereby authorized to draw and deliver a check a. in the amount of \$39,075.00 made payable to Christine Smith and Warren and Allen LLP.
- Risk Management Services will execute a payment authorization in the b. amount set forth in sub-paragraph (a) above.
- Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
