

ORDINANCE No. 187183

* Change the wage scale for the District Council of Trade Unions represented classification of Records Specialist. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary range of the DCTU represented classification Records Specialist, effective February 10, 2015.
2. AFSCME, Local 189, which is a signatory member of the District Council of Trade Unions (DCTU), and the City of Portland have agreed to changes to this classification and the following compensation rate.

NOW, THEREFORE, the Council directs:


