## **ORDINANCE No.** 187188

Authorize grant agreements or Intergovernmental Agreements with 13 community groups related to the Community Watershed Stewardship Program up to \$100,000 total (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland City Council adopted the Clean River Program on April 6, 1990. In 1995, the Bureau of Environmental Services developed the Community Watershed Stewardship Program (CWSP) to provide grant funds and technical assistance for citizen-led watershed projects. On March 8, 2006, the Council adopted the 2005 Portland Watershed Management Plan which describes actions for watershed health including citizen led activities such as natural area revegetation, education, involvement and stewardship. On May 2, 2012, Council adopted Resolution #36920, reaffirming the City's commitment to watershed health.
- 2. These grants have been selected for FY15-16: Depave Saints Peter & Paul Episcopal Church (\$10,000); Dharma Rain Zen Center Siskiyou Community Garden (\$7,448); Linnton Neighborhood Association Restoration (\$6,200); Columbia Slough Watershed Council Youth Leadership in Restoration (\$8,600); Habitat for Humanity Cully Rain Gardens in the Home and on the Street (\$9,940); Zomi Community Youth Garden and Watershed Project (\$6,000); Friends of Tryon Creek Environmental Education for All (\$8,700); Southwest Neighborhoods African Youth Community Organization Watershed Team (\$6,000); Lents Springwater Habitat Restoration Project (\$9,875); Oregon Bhutanese Community Organization Community Garden (\$6,000); Rose CDC Lents Youth Initiative (\$9,885); Portland Youth Builders Educational Eco Roof (\$5,352); and Iraqi Society of Oregon Mesopotamians on the Banks of the Willamette (\$6,000)
- 3. The established cost is \$100,000. Funds are available in the Sewer System Operating Fund, FY15-16 Budget, Bureau of Environmental Services, Cost Center ESWS000007.

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to execute grant agreements and intergovernmental agreements for the purpose described in Section 1, in substantially the same forms as Exhibits A and B attached herein, in the amount of \$100,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


