To whom it may concern,

I am requesting to address the City Council regarding the replacement of a 12" PGE pole for a 18" PGE pole within the right of way adjacent to the property 915 SE 71st ave. The purpose of the pole replacement is to accommodate a proposed T-Mobile antenna installation on a PGE utility pole. My concerns pertain to the AASHTO guidelines on horizontal clearances to obstructions on local residential streets as outlined by the Office of Transportation and reported to the City Council in 2008 by Steve Townsen through their findings and guidelines entitled "Designing for Truck Movements and Other Large Vehicles in Portland". This was adopted October 8th, 2008 and calls for a recommended 1.5' or more set back from face of curb for residential streets. Due to the sub standard pedestrian corridor the pole would need to be installed tight to the curb thus have just 6" of horizontal clearance.


