

# Ordinance No. 21686

An Ordinance adopting the report of the City Engineer in the matter of the proposed opening, laying out and establishing of Bryant Street from the west line of Union Avenue to the east line of ~~Street~~ Vancouver Avenue

*The City of Portland does ordain as follows:*

SECTION I.

WHEREAS, The Council, of the City of Portland deeming it expedient to open, lay out and establish Bryant Street from the west line of Union Avenue to the east line of Vancouver Avenue ~~Street~~,

did; on the 23rd day of June, 1910, direct the City

Engineer to survey the same, and to mark the boundaries thereof, and to make a plat of such survey, and a written report containing a full and perfect description of such proposed street and the boundaries thereof and of the portion of each lot, tract, or part of either to be appropriated for such street, and the City Engineer having made such survey, plat and report and filed such plat and report in the office of the Auditor

of the City of Portland on the 12th day of July, 1910

and the said plat and report being satisfactory to the Council, is now hereby adopted,

TO THE HONORABLE MAYOR AND COUNCIL  
OF THE CITY OF PORTLAND:

GENTLEMEN:

In pursuance of a resolution adopted by your Honorable Body at your meeting of June 23d, 1910, directing me to survey and mark the boundaries of a proposed opening, laying-out and establishing of Bryant Street from the west line of Union Avenue to the east line of Vancouver Avenue, said street to be 60 feet in width, to be laid out by making the north line six (6) feet north of and parallel to the present north line, and by making the south line fifty-four (54) feet south of and parallel to the present north line, I have surveyed and marked the boundaries of the proposed opening, laying-out and establishing of Bryant Street and herein submit my report together with a plat of said survey.

The proposed opening, laying-out and establishing of Bryant Street is 60 feet in width and is more particularly bounded and described as follows:

Beginning at a point in the west line of Union Avenue 6 feet north of, the north line of Bryant Street as laid out in Love's Addition; and running thence west, 6 feet north of and parallel to the said north line of Bryant Street, to the east line of Vancouver Avenue; thence south, along the east line of said Vancouver Avenue, to a point 60 feet distant from, at right angles, to the north line of the proposed opening, laying-out and establishing of Bryant Street, as above described; thence east, 60 feet south of and parallel to the north line of the proposed opening, laying-out, and establishing of Bryant Street, as above described, to the west line of Union Avenue; thence north, along the east line of Union Avenue, 60 feet to place of beginning.

The proposed opening, laying-out and establishing

of Bryant Street, as above described, will include and  
necessitate the appropriation to public use, the following  
described parcels or tracts of land, to-wit:

All that part of the following lots lying south of  
the north line of the proposed opening, laying-out and es-  
tablishing of Bryant Street, as above described:

Lot 7, Block 9, Loveleigh, containing 600 square feet
