An Ordinance accepting certain property for Street purposes.

The City of Portland does ordain as follows: Section 1. That the following described property be and is hereby accepted by the City of Portland for street purposes.

Beginning at a point on the west line of East 63rd Street formerly Gilham Avenue, which point is two hundred sixty-two and seventy-five hundredths(262.75) feet north and four and five-tenths (4.5) feet east of the southwest corner of Sec. 32, Twp. 1 N, Rng. 2 E, of W.M.; thence running northerly along the said west line of East 63rd Street, a distance of one hundred seven and six-tenths (107.6) feet to the north line of said grantor's land; thence westerly along the north line of said grantor's land, a distance of five and fivetenths (5.5) feet to a point; thence southerly five and fivetenths (5.5) feet distant from and parallel to the said west line of East 63rd Street, a distance of one hundred seven and six-tenths (107.6) feet to the south line of said grantor's land; thence easterly along the south line of said land five and five-tenths (5.5) feet to the place of beginning, being a strip of land five and five-tenths (5.5) feet in width, lying west of and adjoining the west side line of East 63rd Street. Commencing at a point on the south line of Broadway, one hundred and fifty (150) feet westerly of the west line of Vancouver Avenue; and running thence westerly along the south line of Broadway a distance of fifty (50) feet to a point; th nee southerly parallel to the west line of Vancouver Avenue, a distance of fifty (50) feet to the southwest corner of Lot (8) in block (3), as shown on the recorded plat of Elizabeth Irving's Addition to East Portland, now Fortland; thence running northeasterly in a straight line to the place of beginning. The same being a part of said Lot (8) in Block (3) and is intended to be a lateral extension of Broadway.

Section 2. That the Auditor of the City of Portland be and is hereby directed to have the deeds to the property described in Section 1 of this ordinance placed on record.
