Ordinance No. 26564.

An Ordinance to repeal certain proceedings for the opening, laying out and establishing of streets.

The City of Portland does ordain as follows:

Section 1. That the proceedings for the opening, laying out and establishing of the streets and avenues hereinafter mentioned, which were in force and effect November 4, 1912, be and are hereby discontinued, and all other proceedings for the opening, laying out and establishing of streets and avenues, whether enumerated in this ordinance or not, which were in force and effect on said fourth day of November, 1912, and in which the report of the Viewers had not been adopted on said date, be and are hereby discontinued:

Alley in block 31, Central Albina, from center line of block 31, Central Albina, to north line of Fremont Street;

Alberta Street from 100 feet west of the west line of East Thirty-third Street to 100 feet east of the east line of East Thirty-third Street;

Ainsworth Avenue from the east line of East Thirty-third Street, north, to east line of East Forty-second Street, north, extended through;

Alley 16 feet wide, from a line 13 feet south of the northeast corner of lot 12, block 4, Central Albina, to east line of Congress Street;

Gilbert Street from the north line of Willis Boulevard to the south line of Edwards Street;

Halsey Street from the east line of York, extended northerly, to the northwesterly line of Sandy Road;

Hassalo Street from the east line of East Seventysixth Street to the west line of East Seventy-seventh Street;

Holman Street from 26.97 feet east of the east line of East Thirteenth Street to the east line of East Eighth Street;

Holman Street from the west line of East Seventh Street to the east line of Union Avenue:

Overlook Boulevard from the south line of block 11, Griswold Tract, to south line of Griswold Avenue;

Piedmont Lane from the north line of Killingsworth Avenue to south line of Ainsworth Avenue;

Powell Street from the east line of Milwaukie Street to the west line of East Nineteenth Street;

Fortieth Avenue, Southeast, from Sixty-second Street, Southeast, to Sixty-seventh Street, Southeast;

Forty-first Street, Southeast, from a southerly extension of the west line of Vickery Avenue as laid out in Washington Addition to East Portland, to the east line of Hampton Kelly Donation Land Claim;

East Forty-first Street from the scuth line of tracts "I" and "J", of Richmond, to the south line of Karl Street, Waverleigh Heights;

East Forty-third Street from the south line of Belmont Street to the north line of East Taylor Street;

East Forty-third Street from the southwest corner of lot 6, block 4, Glencoe Park, extended, to northwest corner of lot 5, block 4, Glencoe Park;

East Forty-sixth Street from the north line of Arcadia Addition to south line of East Salmon Street; East Forty-seventh Street from the south line of East Salmon Street to the north line of Hawthorne Avenue:
