

An Ordinance vacating the unnamed alley separating Lot 1, Block 65 and Lot 1, Block 59, all in Carters Addition to Portland, according to the duly recorded map and plat thereof.

WHEREAS, due notice was given by advertisement for four consecutive weeks in the Portland Daily Abstract, the City official newspaper of the said City of Portland (the first publication of said notice being in the issue of December 10, 1913, of said newspaper, and the last publication of said notice being in the issue of January 7, 1914, of said newspaper) that at a regular meeting of the Council of the said City of Portland to be held on Wednesday, the 14th day of January, 1914, a petition would be presented to said Council by M. C. George, Mary B. George, Jessie Ruth Jones and Gwilyn G. Jones, praying for the vacation of the unnamed alley separating Lot 1, Block 65 and Lot 1, Block 59, all in Carters Addition to Portland, in Multnomah County, State of Oregon, according to the duly recorded map and plat thereof, which notice, with due proof of its publication subscribed and sworn to by W. T. Phillips, foreman of the printer of the said Portland Daily Abstract, is filed with the Auditor of said City; and,

WHEREAS, said petition was duly advertised and presented to said Council on the date named in said notice, and within named, which petition duly set forth the particular description of the said alley proposed in said petition to be vacated, and the reason for such vacation, to which there was appended as a part thereof and as a basis for said vacation and for the granting of the prayer of said

petition, the written consent, duly acknowledged before a Notary Public in and for the State of Oregon, of all of the owners in fee simple of all of the real estate fronting on both sides of the said alley proposed in said petition to be vacated, ~~and for the entire length thereof~~, and the whole thereof, it not being continuous in either direction,

WHEREAS, the said Council, upon the presentation of the said petition and the filing of proof of said notice, did fix a meeting of said Council on Wednesday, the 28th day of January, 1914, as the regular time and place of hearing said petition and objections thereto, if any be filed; and

WHEREAS, said petition was duly called on the 28th day of January, 1914, and no objections to said petition or the granting thereof, or to the vacation of the said alley proposed therein to be vacated have been filed; and,

WHEREAS, said Council has ascertained and determined and does hereby cause it to be made a matter of record, whatsoever is hereinbefore set forth, and that the public interest will not be prejudiced by the said vacation prayed for, and that the same should be vacated as a whole, and the Council so finding; now, therefore,

The City of Portland does ordain as follows:

Section 1. That all the unnamed sixteen (16) foot alley between Lot 1, Block 59 and Lot 1, Block 65, all in Carters Addition to Portland, beginning at the east side of what is now and was formerly known as Ford Street Drive and extending easterly along aforesaid lots in aforesaid blocks, sixty-three (63) feet to old thirty (30) foot Prospect Drive, now vacated, as described on plat recorded in Book "W", Page 55 of Record of Deeds of

Multnomah County, Oregon, and Book "P", Page 490 thereof,
and which sixty-three (63) foot street does not reach but
terminates thirty-one (31) feet more or less short of the
now dedicated thirty(30) foot Prospect Drive in Book 400,
Page 65 of aforesaid records, all on file in the office
of the County Clerk of aforesaid Multnomah County, State
of Oregon, be and the same is hereby vacated.
